Discussion/interpretation:

Chapter 461 administrative rules govern Self-Sufficiency Programs (SSP) and Aging and People with Disabilities (APD) medical program eligibility. This transmittal provides summaries and text edits for administrative rules changes related to the Employment Related Day Care (ERDC) program moving from Oregon Department of Human

Services (ODHS) to Department of Early Learning Care (DELC) made effective July 1, 2023.

RULE TITLE: Citizenship and Noncitizen Status Requirements

RULE SUMMARY: OAR 461-120-0110 is being amended to remove the ERDC program from Chapter 461 to transfer it from ODHS to DELC as required by House Bill 3073 (2021 regular session). It is also being amended to make clear that citizens of federally-recognized, sovereign American Indian and Alaska Native nations as defined in section (4)(e) of the Indian Self-Determination and Education Act (25 U.S.C. 450b(e)), are citizens of their sovereign nation and of the United States.

RULE TITLE: Noncitizen Status Requirements

RULE SUMMARY: OAR 461-120-0125 is being amended to remove the ERDC program from Chapter 461 to transfer it from ODHS to DELC as required by House Bill 3073 (2021 regular session). It is also being amended to refer to Indigenous, First Nation, Inuit, Métis, and Aboriginal individuals born in Canada in a more respectful way and to remove reference to American Indian and Alaska Native tribal nation members from the noncitizen section of the rule as these individuals are United States citizens, and citizens of their sovereign tribal nation.
