New Medicaid contracts have been awarded to In-Home Care Agencies through a Request for Application (RFA) process that closed on 06/01/05. Contracts were awarded on 06/15/05, and became effective 07/01/05. Each Contractor will receive one State contract, rather than one contract per area served.

The In-Home Care Agency must be licensed through DHS, Public Health.

Each Contractor will have one provider number per area served. The change in provider number will be effective 09/01/05.

Each SPD/AAA office will be responsible for updating the 546 hourly service rates.
