**Message:**

OregonSaves is a new retirement benefit for homecare workers and personal care attendants. The benefit was negotiated on their behalf by SEIU, Local 503 and is included in the 2019-2021 Collective Bargaining Agreement.

For those who choose to participate, five percent (5%) of their gross wages are automatically deducted from their pay and invested into their personal Roth Individual Retirement Arrangement (IRA). The deduction is reflected on their remittance advice or pay stub.

All workers were invited to participate, and initial deductions were taken from their Feb. 16, 2021 service payment for the service period Jan. 17, 2021 – Jan. 30, 2021 unless they opted-out. Workers were given the opportunity to opt-out of participation but had to do so by noon on Feb. 4, 2021.

Workers may access their funds, increase their deductions, stop deductions, or withdraw their money at any time through the OregonSaves website or by contacting OregonSaves by phone.
