The deadline to complete required refresher training for homecare workers, personal support workers, and personal care attendants, enrolled prior to Sept. 1, 2021, is June 30, 2022.

Unless a worker has a current certification through the Oregon Home Care Commission, workers must complete the following to receive credit for completing refresher training:

- Online Refresher
- Refresher Workshop and survey

Termination notices will not be issued in July. The final list of workers who have completed training will not be available from Carewell SEIU 503 Training until mid-July. In addition, approximately 4,000 workers have requested to complete an offline version of the training. Termination notices will not be issued until it is verified all accommodations have been fulfilled, and materials received have been processed and

recorded as complete.

Central office will issue an updated information memorandum before termination notices are issued.

During conversation with workers, or the individuals they support, please:

- Reassure workers and consumers that termination notices will not be issued in July.
- Reassure workers who report they mailed in training materials to Carewell and have not received confirmation that central office will verify the materials have been received and processed before any termination notices are issued.
- Direct workers who have requested an accommodation prior to the deadline and it has not been fulfilled to contact the Member Assistance Center (MAC) with SEIU at 1-844-503-7348 or the Oregon Home Care Commission's Customer Relations Unit at 877-624-6080.
