Version 2 includes parameters around how many overtime hours a PSW can be approved to work in a 24-hour period.

Discussion/Interpretation

Due to the actions necessary to reduce the spread of COVID-19, Case Management Entities are authorized to grant exceptional PSW hours by email or text.

This may occur if:

- A PSW has or believes they have been exposed to the virus or are providing care to a family member of their own;
- An individual has PSWs who are unable or unwilling to provide supports to the individual, leaving the individual with fewer PSWs;
- An individual is unable to attend DSA or worksite;
- An individual under the age of 21 is unable to attend school; or
- An agency provider is unable to provide a DSP

If an increase in PSW hours or overtime is necessary due to a workforce shortage the Services Coordinator or Personal Agent may temporarily authorize an increase to a PSW's weekly hours. A workforce shortage is determined when a PSW who typically provide services to an individual is unavailable due to COVID-19.

- PSW overtime approval may not exceed 16 hours per day.
- PSW overtime approvals may be granted for a PSW to work with multiple or additional individuals.
