

Service Categories and Types of Assistance

When authorizing a service plan in Oregon ACCESS, it's important to look in ONE first to make sure the type of Service Category/Benefit matches the individual's authorized medical program. If the approved benefit doesn't match the authorized medical program, provider payments will not be issued. This guide helps APD/AAA Case Managers identify which service categories correspond with individual medical TOAs in ONE.

Start by searching ONE to determine the individual's authorized medical program. This is viewable on the Case Summary by looking at the Currently Associated Eligibility Determination Groups (EDGs). This individual was receiving ADLT, which is a MAGI TOA. ADLT terminated 7/31/2021 and their benefit changed to SSIR, which is an OSIPM TOA, on 8/1/2021.

In Oregon ACCESS, we can see this individual is currently receiving State Plan Personal Care (SPPC) under a MAGI benefit (BPO). Because they're now receiving OSIPM, we need to change their Service Category/Benefit to BPA with an 8/1 effective date to match the OSIPM TOA authorized in ONE.

End the current service plan using the date of the TOA change. In this case, the individual's MAGI ADLT closed on 7/31/21, so that's our BPO end date. Start a new benefit line corresponding with the individual's current TOA. In this example, the BPA benefit begins 8/1/2021 because that's the OSIPM effective date.

Once the new Service Category/Benefit is approved, update the relevant provider payment system. If the individual is receiving in-

home services, a new SDS 546PC/SDS 546N needs to be completed. Depending on service periods, you may need to contact the individual to determine how many hours have already been used in the pay period and pro-rate remaining hours on the new 546PC/546N. If the individual is in a community-based care setting, the 512 needs to be "touched" with the effective date of the TOA change. For example, if MAGI ADLT ends 7/31/21 and OSIPMOAA begins 8/1/21, the effective date for the 512 would be 8/1/21.

OSIPM TOAs should have a corresponding BPA (SPPC), APD, ICP, PACE, or NFC Service Category/Benefit as appropriate to the individual's person-centered service plan. MAGI TOAs should have a BPO (SPPC), KPS, PACE, or NFC Service Category/Benefit. Oregon Project Independence (OPI) cannot co-exist with an OHP Plus benefit.
