**Message:** Based on the 2013-2015 Adult Foster Home Collective Bargaining Agreement, Appendix C, there has been a change to Specific Need Contract Homes who provide care for individuals with needs related to bariatric care, traumatic brain injuries, memory care, or have needs related to neurological or neuro-gerontological care. This change is memorialized in new contracts for existing providers who currently have Specific Need Contracts in Adult Foster Homes serving these populations and meet the intent of the article.

The following are the collectively bargained rates for the new contract levels:
