Overview

SOCP provides 24-hour care and supervision to people in Oregon with developmental disabilities who represent the most risk to the public at large, their peers, or themselves. SOCP provides residential care and vocational support, which includes health and medical care, behavioral support, personal care, vocational training, job support, education, recreation, psychological services and community integration.

SOCP is dedicated to providing the support necessary to maintain the quality of life, achieve the highest possible level of independence and promote social opportunities, which benefit the individuals and the community. Each individual residing in the program has an Individual Support Plan (ISP) that emphasizes community integration, independence, and productivity, has daily implementation agendas, and is monitored by county case management.

Staff Employment Opportunities

SOCP hires employees through the State recruitment process. Positions available are Habilitative Training Technician 2, Mental Health Therapist, Registered Nurses, Licensed Practical Nurses, Respiratory Therapists, Principle Executive Manager A & B, Trainer/Behavior Specialists and Training and Development Specialists.

Admission into and out of SOCP: Individuals living in SOCP enter/exit the program through referral of the County Service Coordinators.
