ID Cards

Vehicles/Travel

Reminder: We all need to do our part and make sure that when we are traveling to use state vehicles. If you do have permission to use your own vehicle you must first fill out the DAS form "REQUEST TO USE MY PERSONAL VEHICLE ON STATE BUSINESS" and you must have your manager's signature.

Clinical Services

What is a 427? A "427" is a process of petitioning the court under Chapter 427 for persons with mental retardation of the Oregon Revised Statute, for a civil commitment. This civil commitment means an individual will be civilly committed to DHS for one year. This allows SOCP to have legal authority to serve an individual who may not want services from SOCP but who needs our level of support. It would give the local authorities the mechanism to return individuals to an SOCP home should they attempt to leave. We are in the process of petitioning the court for civil commitment on several individuals currently being served by SOCP. The reason for petitioning can be different for each individual. Before we can petition, however, we need to have proof of the individual's mental retardation, which is established by conducting a psychological evaluation to determine the level of retardation and/or developmental disability. As staff, it is important to be supportive of an individual going through this process, as it can be scary and stressful.



Safety Update 2007 Earthquake Drill
