Voter registration forms guide

All forms are ordered through the FBOS.

- 1. **SEL 500 and 500A**, Oregon Voter Registration Form Self Mailer in English and Spanish(A): Tarjeta de Inscripción de Elector de Oregon
 - Has a lick-and-stick strip down one side;
 - Must be in the lobby at all times;
 - Staff is never to use this form for any reason!
- 2. **SEL 500LP**, *Oregon Voter Registration Form*
 - Use with an SEL 503D.
- 3. **SEL 503 and 503A**, Oregon Voter Registration Form with Declination, in English and Spanish (A): Inscripción de Elector de Oregon
 - With the tear off declination on the right side;
 - This is the only registration form staff may hand or mail to a consumer or applicant.
- 4. **SEL 503D**, Oregon Voter Registration Declination
 - Please default to the electronic version;
 - Mark Yes if the consumer wants the registration card for any reason and NO if they do not;
 - Use this only if the consumer/applicant has not completed an approved DHS forms with the voter registration question printed on it.
- 5. **SEL 503P**, Register and Vote poster
 - Display in the lobby.
- 6. **SEL 504**, Agency Voter Registration Reporting Form
 - Submitted via the internet by the site coordinator once every seven (7) calendar days with the total number of voter registration cards sent to County Elections by the branch;
 - If no cards were completed, complete the report with a 0.

- 7. **SEL 504C**, *NVRA Site Coordinator Change Form*
 - Submitted via the internet;
 - Must be completed within ten (10) <u>calendar</u> days of the change.
- 8. **SEL 516**, Voter Registration Envelope
 - All voter registration cards must be placed in an SEL 516 before mailing to county elections.
- 9. **SEL 540**, Signature Stamp Attestation
 - Use when the consumer or applicant self-identifies they are using a signature stamp due to a disability or disabling condition;
 - The form changes the consumer/applicants legal voting signature to the signature;
 - The form may be completed at any time and does not need to accompany a completed SEL 503;
 - Send to the local County Election office with the other voter registration cards in the SEL 516 envelope.
- 10. **SEL 550**, Application to Exempt Residence Address from Disclosure as a Public Record
 - Use when a consumer/applicant has a DV situation or another reason to not have their personal information available through a public records search;
 - Anyone may request to be exempted, not everyone will be the Elections office has discretion;
 - The requestor must take their form to a County Elections office in person to be considered for exemption;
 - The section for legal documentation is *optional*.
- 11. **SEL 585**, Oregon Secretary of State Elections Division Contact Information
 - Hand out the form to anyone who has concerns with the voter registration requirements;
 - The Oregon Secretary of State's office will use translation services as needed;
 - Available in English, Spanish, Russian, and Vietnamese.
