Public Consulting Group (PCG), an independent consulting firm, was contracted to conduct the time and motion study. PCG will conduct the study by having their staff go to the homes of in-home service consumers to observe and document ADL, IADL and medical treatment assistance being delivered to consumers by HCWs.</p> <p>Case managers will need to act as a liaison between PCG and consumers selected to participate in the time and motion study. Case managers will be notified of any consumers in their caseload who have been selected for the time and motion study approximately two weeks before PCG Staff's first scheduled visits to consumers' homes.
