APD-IM-16- 021	2/22/16	Issuing Vouchers Prior to the Next Pay Period - Field offices have up to eleven business days to process correctly completed vouchers for homecare workers after the end of each pay period. In some instances field offices will not issue a voucher for the next pay period until the previous one has been processed resulting in some homecare workers not being able to turn in their voucher within three business days after the end of the pay period.
		Immediately begin issuing out vouchers prior to the start of the next pay period whenever possible. This may include sending out the next two pay vouchers when processing the current one for payment or sending out the next voucher for all homecare workers even if the prior voucher has not yet been processed. Participation Fee Standards for EPD effective March 1, 2106 - Effective March 1, 2016, the increase to the Federal Poverty Level (FPL) will increase the adjusted income standards for Medicare Savings Programs (QMB/SMB/SMF) and the Employed Persons with Disabilities (OSIPM-EPD) DHS 0079 (08/15) program. The OSIPM-EPD Participate Fee

		Standards will also increase effective March 1, 2016. See transmittal for details.
APD-AR-16- 016	2/23/16	SMB/SMF/SBI Clients Who May Qualify for QMB/SMB/SMF as of March 1 - The 2016 Federal Poverty Levels have been released, which will change the income standards for Medicare Savings Programs effective March 1, 2016. The FPL increased slightly this year, and with no SSA cost of living adjustment, some SMB clients may qualify for QMB, some SMF clients may qualify for SMB, and some SBI clients may qualify for SMF effective March 1st.
