| <a href="#"><u><b>SS-IM-16-001</b></u></a>  | 1/12/16           | <p><b>Reactivation and revision of DHS 1467</b> - The <i>Employment Assessment: OFSET and ABAWD Determinations</i> (<a href="#"><u>DHS1467</u></a>) form has been reactivated and revised to assist staff determining if someone is subject to OFSET work requirements and/or ABAWD time limits.</p> <p>Although customers residing in Multnomah County and Washington County are the only people subject to the ABAWD time limits, the OFSET and ABAWD policies affect the entire state. The HCW is unable to indicate how many miles he or she has actually driven for the individual during the pay period. This includes licensed and license-exempt centers; Certified Centers (CNT), Enhanced exempt Centers (QEC) and Standard exempt Centers (NQC). See transmittal for details.</p>  |

It is also important not to share confidential client information with the applicant.
