<a href="#"><u>APD-PT-16-027</u></a>	7/5/16	<b>Requirement to Pursue Assets</b> Beginning July 1, 2016, all benefit group members must pursue monthly or periodic payments or distributions from a pension or retirement fund (see OAR <a href="#"><u>461-145-0380</u></a> ) if eligible to do so under the terms of the plan. OAR <a href="#"><u>461-120-0330</u></a> about the requirement to pursue assets is being amended; see transmittal for details
<a href="#"><u>OHP-IM-16-025</u></a>	7/5/16	<b>Oregon Health Plan covers long-term acute care hospital services effective July 1, 2016</b> - The Health Systems Division attached explaining how to transfer OHP members to an enrolled long-term acute care hospital (LTAC) facility. <a href="#"><u>SS-IM-16-035</u></a>	7/9/16	<b>Replacing WPAY screen with SAPH and SAPD screens</b> - The Division of Child Support (DCS) is replacing mainframe screen WPAY with mainframe screens SAPD and SAPH which display the history of payments received on a child support case from 1982 to the present. SAPD and SAPH are used in conjunction to access child support payment history. See transmittal for screen access details.
<a href="#"><u>APD-AR-16-048</u></a>	07/7/16	<b>24 month SNAP certification</b> - Effective July 7, 2016, APD/AAA branches will have the ability to set up a 24 month certification for SNAP households who meet the NED criteria (all HH members are persons with a disability or over 60 years old, with no earned income). Branches may begin using the 24 month certification for eligible SNAP recipients beginning August 1, 2016 for certifications or re-certifications. See transmittal for details.
<a href="#"><u>APD-AR-16-049</u></a>	07/7/16	<b>Oregon Minimum Wage Increases: Supplemental</b> -SB 1532 creates a three schedule system of annual minimum wage increases for July 1, 2016 through June 30, 2023, after

		<p>which the minimum wage increase will be tied to the Consumer Price Index.</p> <p>The amount of the minimum wage will be determined by the address of the employer, not the address of the employee. See transmittal for increase schedule and amounts effective July 1, 2016.</p>
<a href="#"><u>APD-IM-16-058</u></a>	7/7/16	<p><b>New APD Adult Foster Home Rules, Effective 6/28/16 - <a href="#"><u>OAR chapter 411, division 50</u></a>, <i>Adult Foster Homes – Licensure of Adult Foster Homes for Adults Who are Older or Adults with Physical Disabilities</i> has been updated. The new rules went into effect on June 28, 2016; a summary of the changes, including the changes that were implemented with the temporary rules that went into effect on January 1, 2016, will be sent to Licensing staff and providers very soon.
