<a href="#"><u>OPAR-AR-16-001</u></a>	6/6/16	<b>New CMU Web Based Form: Replaces the MSC0148</b> - Effective June 6, 2016, all staff should submit requests to CMU using the new secure web form. To access the web form, go to: <a href="http://www.cmurequest.org">www.cmurequest.org</a> . To launch the form, click the <i>Submit CMU Request Now</i> button at the bottom of the page. <a href="#"><u>APD-AR-16-039</u></a>	6/7/16	<b>Oregon Project Independence and Medicaid Eligibility</b> - Using the database of consumer information found in Oregon Access and MMIS, APD is now creating a report APD 1091 monthly to identify consumers who are coded for both a full Medicaid program (usually OSIPM but also includes MAGI) and OPI. If the consumer is on “full” Medicaid and wants to continue to receive “full” Medicaid, the OPI services must be closed according to AAA procedure.  The report is not showing those consumers who have SNAP or a Medicare Savings Program only (e.g. P2 QMB, P2 SMB or P2 SMF) and OPI. See transmittal for details.
<a href="#"><u>SS-AR-16-007</u></a>	6/8/16	<b>Discretionary Exemptions based on preferred language ending on June 30, 2016 for ABAWDs subject to the time limits in non-waiver counties</b> - Discretionary exemptions end June 30, 2016; those mandatory customers who are still not complying with ABAWD work requirements or do not meet an exemption reason (work registration codes 2 - 9) need to have their cases closed with a timely notice. <a href="#"><u>SS-PT-16-011</u></a>	6/8/16	<b>Child Care Provider Requirements rule change</b> - A sibling who lives in the same home as a child in the filing group is no longer eligible to receive DHS child care subsidy payments. See transmittal for details.

<a href="#"><u>APD-IM-16-051</u></a>	6/9/16	<b>Senior Farm Direct Nutrition Program 2016 Update -</b> Over 43,000 seniors who received invitation letters in late April for the 2016 Senior Farm Direct Nutrition program have returned their response cards. The one-time \$24 checks for use at farmers markets and farm stands by October 31 will be mailed out starting later this week. See transmittal for details.
