The letter briefly describes the ERA program, and informs the client of the amount of cash assistance they received from DHS during the previous year (2015) which must be reported to the Department of Revenue when they

		apply for ERA. The letter advises the client to contact the Department of Revenue if they have any questions about the program and the local office if they believe the amount of assistance included in the letter is wrong. See transmittal for details.
