		If no suitable representative is available to the consumer, case managers shall offer the consumer service benefits in other long-term or community-based care settings, and offer the services from in-home agencies (if available). See transmittal for details.

If HCWs wish to cancel or modify their option for withholding an additional amount from each of their paychecks, they must complete a new Form W-4 and submit it to their local APD/AAA office. The information is to be entered into the Financial/Tax screen in Oregon ACCESS. See transmittal for details.
