<a href="#"><u>APD-AR-16-072</u></a>	10/12/16	<b>Pacific Source MAPDP Plan change effective Jan 1</b> - Pacific Source will have a plan change for their Medicare advantage plan for 2017 which will impact dual eligible clients enrolled in the Pacific Source Medicare Essential (H3864-14) HMO. This plan will no longer be premium free for dual eligible consumers; the change will require members to select the new Pacific Source Essential Rx (H3864-027)MA plan to continue receiving the premium discount and same benefits. <a href="#"><u>OHP IM 16-028</u></a>	10/13/14	<b>Oregon Health Plan changes effective October 1, 2016, and January 1, 2017</b> - OHA is making several changes to comply with a January 28, 2016 Informational Bulletin from the Center for Medicaid & CHIP Services (CMCS). That bulletin requires certain changes in the Oregon Health Plan including but not limited to removal of all OHP copayment requirements. See transmittal for details.
<a href="#"><u>APD-IM-16-098</u></a>	10/14/16	<b>HCW Pay Process Date Changes</b> - Staff now have seven (7) business days (previously eight (8) business days) to process correctly completed vouchers. If the seventh day lands on a Friday then the voucher pay process day must be on Thursday. This change will become effective for first pay date in November. See transmittal for details.
