<u>APD-AR-16-068</u>	9/27/16	Expedited Denial Process when coordinating DME for fee-for-service consumers - KPlan currently requires written denials from Health Systems Division or CCOs to process requests to cover DME costs for consumers.
		The intent of the <u>MSC 373</u> , <i>Oregon Health Benefits Inquiry</i> <i>Request</i> form is to streamline the process for open card/fee- for-service individuals enrolled in long term care services who need non-covered Durable Medical Equipment (DME) to increase their independence. When a verbal denial for equipment is received use this form to get a quick written denial required to submit an <u>SDS 3406</u> request for K Plan Ancillary Services.
