		OAR 461-130-0327 about good cause is being amended to expand the reasons are considered good cause in the SNAP program in the context of work requirements for able-bodied adults without dependents (ABAWD).
		OAR 461-135-0520 about time limits and work requirements for able-bodied adults without dependents (ABAWD) in the SNAP program adds six new SNAP time-limit (non-waivered) counties, clarify self-employment; and to include the reservation land of the Confederated Tribe of Grand Ronde.

		OAR 461-145-0170 is being amended to indicate any energy assistance payment is excluded in the SNAP program, aligning the rule with federal requirements.
		OAR 461-160-0410 is being amended to pro-rate income and deductions for ineligible non-citizens in SNAP.
