<a href="#">APD-PT-18-031</a>	7/9/18	<b>SPAN Notice</b> - APD, NWSDS, and OCWCOG offices, staff must watch a presentation to learn how to complete the four Service Plan and Notice, or SPAN, form in <a href="#">ILearn</a> . The new form reduces time spent creating the notice, condenses information pertinent to the consumer, and ensures legal sufficiency. See transmittal for details.

<a href="#">APD-AR-18-045</a>	7/10/18	<b>New CBC Facilities and Changes in Ownership, Name Changes, new Specific Needs contracts, and In Home Care Agency Changes in Ownership and Name changes</b> - For the listed changes of ownership, staff will need to update all consumer records with new provider numbers, close the 512 or 546 and open a new 512 or 546 with the new provider number for consumers who are currently Medicaid eligible.
