<u>SS-PT-18-016</u>	9/14/18	<p>Administrative Rules for Various Self-Sufficiency and Aging & People with Disabilities Programs – See transmittal for a complete list of changes:</p> <p>OAR 461-110-0210, household groups: clarifies how eligibility rules apply individuals residing in a 24-hour mental health residential care setting;</p> <p>OAR 461-115-0040, filing dates: filing dates are no longer set by receipt of an application at a resettlement agency;</p> <p>OAR 461-140-0020, resource availability: states limit on resource availability when there is a legal bar to the sale of the resource applies only in the QMB-DW program;</p> <p>OAR 461-140-0110, periodic income: establishes OSIPM and QMB periodic income is averaged for determining eligibility and calculating liability. Incorporates monthly \$10 earned and \$20 unearned exclusion of combined periodic and lump-sum income;</p> <p>OAR 461-145-0040, burial arrangements and funds: clarifies exclusions of burial funds in OSIPM;</p> <p>OAR 461-145-0330, loans and interest: adds condition warranting a disqualifying;</p>

Excludes retroactive payments for nine-months after receipt for EPD;</p> <p>OAR 461-145-0530, tax refunds: excludes federal tax refunds as income or as a resource in QMB-BAS, QMB-SMB, and QMB-SMF and change how state tax refunds are treated in the QMB programs;</p> <p>OAR 461-155-0526, special need payments for community transition: clarifies who is eligible for payments and under what circumstances;</p> <p>OAR 461-155-0710, special need payments for diversion and transition: removes references to “transition” services and revises description of eligibility requirements;</p> <p>OAR 461-160-0540, income eligibility in QMB and OSIPM: clarifies adjusted income of the financial group must be below the applicable income standard, not the income of the individual;</p> <p>OAR 461-180-0020, effective date for change in income or deductions: changes resulting in eligibility for an APD program with a higher benefit level are effective in accordance with effective dates for initial benefits.</p>
